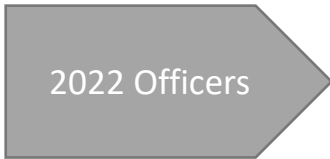
MEETING DETAILS:

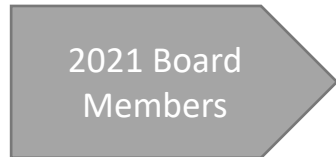
MEMBERSHIP:
